### TRI-PARTITE MEMORANDUM OF UNDERSTANDING

- iii. Share relevant knowledge, expertise and facilities with the NDCH and NLB.
- iv. Support NLB in commercialization initiatives.

**Party C**

- ii. Collaborate on joint research projects with NDCH and JKKN Dental College and Hospital.

Any additional roles and responsibilities may be mutually agreed upon in writing by the Parties.

**TERM**

This MOU shall be effective as of the date first written above and shall continue in force for a period of 2 years unless terminated earlier by mutual written agreement of the Parties.

**TERMINATION**

Any Party may terminate this MOU at any time by providing 90 days written notice to the other Parties.

**CONFIDENTIALITY**

The Parties agree to maintain the confidentiality of any proprietary or sensitive information exchanged during the course of this collaboration in accordance with applicable laws and regulations.

**NO FINANCIAL COMMITMENTS**

This MOU is a non-financial agreement and no Party shall have any financial obligation to the other Parties by virtue of this MOU.




